## Min.567 C10/23-406 Notice of Motion - Ineffective Outcome of National Tree Planting Day

#### **Motion (Hughes/Garrard)**

It is with concern that the community recognises the wasted opportunity and resources spent on promoting and implementing the planting of at least 500 seedlings in Central Park, Botanica - Lidcombe, representing Council's involvement on National Tree Planting Day.

A report is requested to include, but not exhaustive of:

- 1. The circumstances which have resulted in less than 1% of the seedlings in Lidcombe still being in existence.
- Details indicating the comparison of preparation and ongoing maintenance work unsuccessfully undertaken at Lidcombe and the significantly successful preparation and ongoing maintenance work undertaken at Canal Road Park, Greystanes.
- 3. Details as to why hasn't this matter been reported to Council and, further, what circumstances will be established to ensure that this programme is both environmentally and economically sustainable?
